Ruler pocket. Thigh phone pocket with flap and adjustable hook and loop band fastening. Pen pockets. Kneepad pockets. Co-certified together with kneepad type large in accordance with EN 14404-3.

- Workwear logo. Horizontal on left thigh. Max 11x5 cm/4.3x1.9 inches
- Workwear logo. Vertical on right thigh, read from the top downwards. Max 15x5 cm/5.9x1.9 inches
- Workwear logo. Horizontal on right thigh. Max 11x5 cm/4.3x1.9 inches
- Workwear logo. Horizontal on right calf. Max 12x6 cm/4.7x2.3 inches
- Workwear logo. Inside waistband. Max 15x1 cm/5.9x0.3 inches
