Technical info

Fluorescent with reflective tape. The surface treatment makes the product dirt-repellent. Two-toned. Triple stitched seams at leg and crotch. Belt loops. Fly with zip. Front pockets. Reinforced back pockets - one with flap and hook and loop band fastening. Adjustable hammer loop. Thigh pocket with several compartments, flap and adjustable hook and loop band fastening. Ruler pocket. Thigh phone pocket with flap and adjustable hook and loop band fastening. Pen pockets. Kneepad pockets. Co-certified together with kneepad type large in accordance with EN 14404-3.

Twill. Do not soak. Wash separately. The product is certified to retain its properties with 50 domestic washes or 50 industrial washes. The dirt-repellent finish is reactivated by tumble drying according to the washing instructions.

- Workwear logo. Right back pocket. Max 10x5 cm/3.9x1.9 inches
- Workwear logo. Horizontal on left thigh. Max 11x5 cm/4.3x1.9 inches
- Workwear logo. Vertical on right thigh, read from the top downwards. Max 15x5 cm/5.9x1.9 inches
- Workwear logo. Horizontal on right thigh. Max 11x5 cm/4.3x1.9 inches
- Workwear logo. Horizontal on right calf. Max 12x6 cm/4.7x2.3 inches
- Workwear logo. Inside waistband. Max 15x1 cm/5.9x0.3 inches
