Front pockets. Ruler pocket with flap and Kevlar® reinforcement. Adjustable kneepad pockets with CORDURA fabric. Simple individual adjustment of kneepad pocket height. Back pockets with reinforcement and flaps. Thigh pocket with phone pocket and flap with hidden press stud and integrated ID card holder. Detachable ID card holder. Each standard leg length can be lengthened by 3 cm by releasing the internal red stitching. With print effects. Co-certified together with kneepad type large in accordance with EN 14404-3.

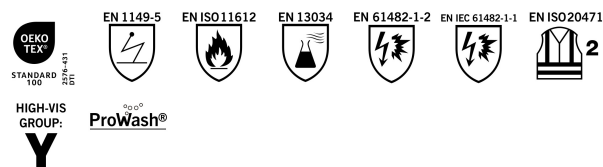
